Staff Child Ratio

(1) Electrical

A multi-outlet adapter, located in the K3,4 classroom (under 7ft), was noted not having protective covers. Teacher was made aware and discrepancy rectified. No further action required.

(2) Signage

Signages are clearly visible and posted within designated areas. No discrepancies noted.

(3) Emergency

- Fire extinguisher check for the month of March was not accomplished for extinguishers located by main entrance door and K-3,4 classroom. The following is recommended:
 - Train staff that are responsible for the area on how to properly inspect a fire extinguisher to assist with maintaining equipment and complying with monthly inspections.

(4) Sanitation

The facility was observed to be clean and sanitized with no lingering odors during time of inspection. No discrepancies noted.

(5) Outdoor

• Outdoor play area is well-maintained, enclosed by a chain-linked fence, and away from main roadways. *No discrepancies noted*.

(6) Capacity

• Capacity requirements are met per the issuance of a valid Occupancy Permit by the CNMI Department of Public Works. *No discrepancies noted.*

(7) Health

 Enrolled children's health information is available. Records for each child kept with respective provider. Allergies, immunization records, and other pertinent information are on file. No discrepancies noted.

(8) Documents

• All pertinent documents are kept in an organized fashion and posted along with valid Licenses, Certificates, and permits. *No discrepancies noted*.

(9) Other

• **K-3,4, classroom:** Scissor was found to be placed in an open area that was accessible to children in the room. The teacher was made aware and scissor placed in a cabinet inaccessible to children. *No further action required.*
